THE GEORGE GORDON FAMILY HISTORY

George Gordon was born in Scotland in 1698 during the reign of William and Mary, a period of extreme religious and political tension and unrest. Born eight years earlier than Benjamin Franklin, he was thirty-six, when in 1734 with his wife and seven children, six of them girls, he arrived in Antrim Township, Pennsylvania, many miles distant from the seat of the government, in what was then Lancaster County, on the foremost frontier of the then English Province of PA. It appears that they entered the land of the adoption through the port of Philadelphia, as did so many of their fellow countrymen.

Although William Penn received his Land Grant in 1681, almost fifty years elapsed before his colony had penetrated beyond the Susquehanna River. Historians have fixed 1730 or 1731 as marking the arrival of the first settlers in what is now Franklin County, although we are told that during the preceding decade or more, a few homes had been established farther westward, by Maryland penetration, on what later proved to be Pennsylvania Territory. Maryland, it will be remembered, had begun colonization in 1632, and was then a century-old province, indicating that it's westward thrust was equally slow and laborious.

Certainly there were very, very few neighbors to greet George Gordon and his family upon arrival in Antrim Township and the earliest years of their lives there, were undoubtedly lived under relatively primitive conditions, in temporary homes, with isolation, danger and hardship their common lot, and with fortitude and endurance vital to their survival.

Not until this intrepid pioneer had spent fourteen long years in the new Antrim had the area been sufficiently developed to provide them with some semblance of local government, when in 1750, Cumberland County was established, with Carlisle as the new county seat. A military outpost about fifty miles distant, which in the absence of roads and bridges probably represented several days journey so that on their very infrequent visits to the new county seat, they were no doubt grateful for the haven of the two intervening posts which had been established at what are now Shippensburg and Chambersburg. Edward Shippen had settled on McLeans Creek during the year 1730, which historians say was the earliest settlement west of the Susquehanna, except for that at York, while in 1734 Benjamin Chambers was granted a Paten on 400 acres of land at the head of Falling Springs, and probably had arrived there a year or two earlier.

It appears that the earliest settlers were almost all so called Scotch Irish or Scots who had gone to Ireland to occupy lands taken from the Irish by Queen Elizabeth and who unhappily soon left that country, many of them actually fleeing for their lives, some years later. Unlike the Irish, who were adherents of the Catholic Church, they were of the Protestant faith and members of the Presbyterian Church, who had never been able to

establish amicable relations with the Irish whose place names they used in profusion throughout the valley despite their Scottish ancestry. It is very probable that George Gordon was one of that group and that like thousands of his fellow countrymen, he embarked from Belfast, and that like many of his fellows, a helpful agrarian background contributed toward his successful adjustment to his new and arduous environment. Very soon after the arrival of the Scotch Irish, many Germans, and in lesser numbers, the English, Irish, and Welsh and others settled in the valley and shared in its development.

A recently discovered genealogy written by an unidentified descendent of George Gordon very simply reads: "George Gordon and wife settled in this place in 1734 and raised a family of eight children. Mary Elizabeth married Crunkilton; Arabela married Joseph McGrew; Sarah married George Dement; Prudence married James Matthews; Rachel married William Matthews; George Junior (have no account of); Ruth married Arthur Eckler; and Henry married Sarah Johnson. Henry Gordon, the youngest son of George Gordon of Scotland, was born on June 8, 1734."

Beyond mention of the names of their husbands, details of the lives of his six daughters are not disclosed, but it is worthy of note that only one of the family names, which they assumed by marriage remain extant in the area, that being Crunkilton or Crunkelton, which four generations later, was again joined with the name of Gordon in the marriage of Ross Snively Gordon, son of Jeremiah Clinton Gordon, to Margaret Jane Crunkelton; and in the marriage of Lewis Crunkelton and his brother David Crunkelton to Effie Gordon and her sister Daisy Gordon, daughters of John Gordon of Michael. The conjecture seems warranted that at least some of George's six daughters probably followed their husbands westward or perhaps southward into Virginia, as definitely did occur in the following generation. The ownership of real estate by Arabela and her husband, Joseph McGrew, provides us with some evidence of their having remained in the area. In 1767 they acquired from Joseph Golliday, 110 acres of land in Antrim Township which on May 24, 1773, they reconveyed to Leigh Master. The original deed of that transfer is still extant, although incomplete, and the signatures thereon, of both Joseph and Arabela are in excellent condition.

We are compelled to wonder what fate befell the sixth child, George Jr., first son and honored namesake of his father, of who we are simply told "have no account of." Did he succumb to illness or catastrophe in his youth? Did the spirit of adventure lure him onward to other frontiers? Was his life sacrificed in battle during the French and Indian War, which began in 1754, when he would have been a young man of twenty-three?

It is interesting to contemplate the courageous pioneering mother of that brood of eight, whose Christian name and whose forebears were omitted from the record which refers to these Scottish born ancestors simply as "George Gordon and wife." Thanks to his industry and thrift, George Gordon acquired both real and personal property and thanks to six generations of descendants, an excellently preserved record of administration upon his estate has been shielded from destruction for two full centuries. From that record we learn that Henry Gordon and Sarah Gordon were named Administrators of his estate. The "Henry Gordon" of course refers to his son Henry, but we cannot be certain to whom

the Sarah Gordon refers. It would seem likely that his daughter Sarah would have been married at an earlier date, in which event her married name of Dement would have been used, hence it would appear that it referred to his widow, or as would seem less probable, that it referred to his daughter-in-law, Sarah Johnson Gordon, the wife of Henry Gordon, who had just turned twenty-five when her father-in-law died. Succeeding generations of Henry's line, by their oft repeated use of the Christian name of Sarah, undoubtedly sought to perpetuate the memory of beloved ancestors, and we find it pleasant to note the probability that this immigrant mother was included among those honored.

Rupp's History of Franklin County provides us with a list of taxables for the year 1751. Although then a part of Cumberland County, the portion thereof situated in the area which now constitutes Franklin County was subdivided into the five townships of Antrim, Guilford, Hamilton, Lurgan and Peters, with Antrim extending all the way to South Mountain. The name of George Gordon appears among the list of 100 taxpayers in Antrim Township with such names as Allison, Crunkilton, Gabriel, Johnson, McDowell, McCaw and Snively, comprising some of his tax paying neighbors.

The estate of George Gordon was administered upon at the county seat at Carlisle, on September 11, 1761, and he undoubtedly died during the summer of that year, thus having lived twenty-seven years in his second land. The place of his burial is not noted, but in all probability his final resting place is somewhere on the homestead he diligently labored to create. Not until the Autumn of 1764 had General Bouquet subdued the Indians in the Allegheny region with any degree of effectiveness, and, in fact, it was during July of that year that Enoch Brown and his pupils were massacred in or near an Antrim Township schoolhouse situated only five or six miles from the Gordon home.

While 1761 marked the end of the French and Indian War, we have much evidence that the area continued to experience the constant menace of attack for five or more years thereafter. Not until 1755 was any fort built in the area, and several of them were constructed as late as 1764, during which latter period Indian atrocities were most numerous. The discordant rumblings that were to culminate in the American Revolution would appear to have been little more than occasional disquieting murmurs of resentment at the time and place of George Gordon's death, which occurred at a time when mutual interest in the halting of French aggression farther westward remained the dominantly prevailing political goal, and rebellion from the English Crown probably never received the serious thought or approbation of George Gordon.

As has been mentioned, Henry Gordon, the youngest son of George Gordon of Scotland was born on June 8, 1734, and according to the sequence of their mention, Henry not only was the youngest son, but the youngest child as well. That he was of American birth and that he was born in Antrim Township, within a very few months after their arrival there would appear to be certain. Born contemporary with Daniel Boone and only two years later than George Washington, he attained his legal majority in 1755, during the second year of the French and Indian War. His adult life completely spanned the historic second half of the eighteenth century. He was forty-two when the Declaration of

Independence was signed, lived thirty-three years thereafter as a citizen of the Commonwealth of PA, USA, and died on August 10, 1809, at the age of seventy-five. His wife, Sarah Johnson Gordon, whose life span included three major wars, was born on July 10, 1736, and died on June 18, 1819, in her eighty-third year. While the date of their marriage is not given, we do note that their first born child, George Gordon, was born on April 17, 1758, when Henry was twenty-three and Sarah was twenty-one. Unfortunately, the place of their burial is not recorded. Like others of their background, they were undoubtedly loyal to the colonists in their struggles for freedom, as is attested to by the fact that their oldest son served in the Continental Army.

Although by tradition the oldest son, George Jr., would have succeeded their father in the ever unfinished business of tilling the soil, of providing more adequate shelter, to the successful management and development of the ancestral homestead, Henry, the youngest son, definitely appears to have assumed full responsibility at the death of their father, George Gordon. Henry was then only twenty-seven, yet it is quite probable that he was already in active control of the farm at that time. That he bought the farm from his father's estate, and that he retained title thereto until his death is reasonably well established. We definitely know that he died possessed of real estate which we have every reason to believe was the same tract upon which he was born.

While we are given few details of the lives of Henry and Sarah, these first generation American born ancestors occupied a fateful and turbulent period of history. Their childhood was spent upon an isolated frontier. The first two decades of their maturity found the area so menaced by Indian depredations that homes frequently had to be abandoned, and Henry was in mid-career, forty to be exact, at the outset of the American Revolution. During the declining years of their lives they experienced a period of extreme economic distress and an almost worthless currency, while abroad the French Revolution raged in a chaotic Europe, and finally three years after the death of her husband, Sarah witnessed another war with England, the War of 1812, and in fact lived four years after that foe had been vanquished.

For the sheer horror of its impact upon their lives, the fifteen year period ending in 1765 undoubtedly was outstanding in these lives which knew many perils. At no time did actual combat in the American Revolution directly touch the immediate frontier upon which they dwelt, although the area was used for the confinement of prisoners of war. On the other hand we find that early Pennsylvania histories are replete with accounts reciting countless atrocities from the settlements west of the Susquehanna, throughout the decade and a half centered upon the seven year period of the French and Indian War.

We are told that Lancaster, across the river and almost one hundred miles eastward, was so fearful of attack that the government in Philadelphia was appealed to for military protection. We have evidence of many such appeals from the westernmost county of Cumberland, and unfortunately for those forebears, their cries for the most part could not be responded to in a substantial way until the final years of that era. Many of the forays death and destruction which occurred farther westward were no doubt French inspired, but historians tell us that in this area much violence resulted from overt acts, including

unprovoked murder by irresponsible white men of evil intent who had inevitably sought the frontiers as a haven of escape and as a place of unfettered privilege. One historian writes "There were some whose principles were rotten" and "The Conococheague towns were infested with a band of desperate marauders and counterfeiters who bid defiance of all law." Certainly in the practical absence of local law enforcement officers, anxiety and fear must have been a frequent guest in the frontier homes of the new Antrim.

We have already referred to George, the first child of Henry and Sarah Gordon, as having been born on April 17, 1758, and as having served in the Continental Army. Our chronicler tells us that this third generation "George" married Nettie Prator; William, the second child, was born July 10, 1760 and died when young; Susannah, the third child, was born on November 7, 1763, and married a Lawrence, whose Christian name was omitted from the record; Elizabeth, their fourth child, was born on December 4, 1765, married Samuel Smith and moved to St. Louis County, Missouri Territory; Alexander, their fifth child, was born on March 10, 1768, and married Margaret Smith. From that union nine children were born, and after Margaret's death, Alexander remarried and his second wife, Hannah, who bore him two children; Sarah, the sixth child of Henry and Sarah, and namesake of her mother, was born on March 28, 1770. She married William Smith, with whom she migrated to Harrison County, Virginia. The seventh and youngest child Mary, was born on July 8, 1772, married Thomas Mason and migrated to St. Louis County, Territory of Missouri. It should be noted that of this family of seven, three of them married Smiths.

On February 18, 1808, Henry Gordon executed his last will and testament, a most interesting document, which has been well cared for, and which is now in the possession of his great, great, great, great, granddaughter, Anna Jane Minnich Noble of Murrysville, PA.

It named his son, Alexander Gordon, and Jacob Snively of Joseph, as its executors, and we note that all sums of money referred to therein were expressed in pounds instead of dollars, the then prevailing official currency. We wonder whether its use simply evidenced the resistance to change of an elderly person or whether English currency actually remained in common use. Although his wife Sarah was seventy-two years of age when the will was written, it provided her with the use of a horse whenever she wanted to ride, thus indicating that after three quarters of a century there still were few, if any, roads providing any degree of comfort for light vehicular traffic.

Again referring to George and Nettie Prator Gordon, we are told that they gave issue to six children, three boys and three girls, but our record then proceeds to name only two of the girls as follows: Henry Gordon who married Elizabeth Smith, thus accounting for the fourth Gordon-Smith marriage in two generations; George, the second child and fourth successive George, married his cousin Nancy Gordon, daughter of Alexander Gordon; Alexander, the third child, bore the name of his uncle, and we are told that he went West, very probably as a single man or youth, since no mention is made of his wife; Elizabeth, the fourth child, married Joseph McLanahan; while Sarah, the fifth and last child mentioned, is reported having married Jacob Weaver.

Whether George and Nettie Gordon remained in the area of their birth appears doubtful. On April 15, 1794, George signed a receipt, still extant, for Three Hundred Pounds of his estate, and since his father's later will refers to this advance on his son's legacy, it appears that at the age of thirty-six he probably migrated westward with his family to seek his fortune. The fact that Alexander, the fifth child, rather than he, the first born, was named executor of his father's will, further points to George's absence from the community.

Of Susannah, Elizabeth, Sarah, and Mary, our genealogist mentions only the names of their husbands and the dates of their birth, but with releases and related original papers which their brother Alexander retained as executor of the estate of their father, Henry Gordon, we have been able to establish the migration to other localities of three of his four daughters. For the sum of One Hundred Fifty Pounds, Susannah Lawrence personally executed a final release on March 4, 1812, in the presence of Henry Gordon and George Gordon and probably lived not far distant from the Gordon homestead. We note that Elizabeth Smith, wife of Samuel, was already a widow when the estate was disbursed, and that on March 11, 1815, she appeared before Andrew Kinkead, a Justice of the Peace of Bonhomme Township, St. Louis County, Territory of Missouri, and executed a power of attorney in which she named her son, Henry Smith, her attorney to effect a satisfactory release of her legacy. We note too that on September 7, 1815, for the sum of Four Hundred Dollars (or Pounds), Henry Smith personally executed a release in the presence of George Gordon, and he undoubtedly journeyed many days to reach the birthplace of his mother for the purpose of collecting her inheritance. On November 16, 1816, Thomas Mason appointed Matthew Kerr his attorney to demand from Alexander Gordon and to receipt for "whatever sum is due to me in right of my wife, Mary," indicating that Mary was then deceased or that a woman could not hold property in the Territory of Missouri where the instrument was executed in the presence of Joseph Charles, a Justice of the Peace, whose authority is certified to by William Clark, Governor.

As concerned Sarah Gordon Smith, who married William Smith and who predeceased her father, distribution appears to have been a bit complex. An excerpt from the will gives us an excellent glimpse of the almost complete absence of communications between areas separated by distances of only a few hundred miles and bears evidence that Sarah Smith and her family by marriage were believably out of touch with her parents and other relatives back home. "To my grandchildren, if any, of my daughter Sarah Smith, deceased, I give and bequeath the sum of One Hundred Fifty Pounds money, to be equally divided amongst them share and share alike, the same males or females, as if their names had been here inserted." Since Henry was uncertain whether his daughter Sarah was survived by any children, we can imagine the amazement of her brother, Alexander, when he discovered that she was survived by eight heirs—four sons and four daughters, who for the most part still resided in Harrison County, Virginia, of which Clarksburg was and is the County Seat, and which about fifty years later became a part of the then new State of West Virginia.

The first release to be signed by a child of Sarah Gordon Smith is that of her son Jeremiah, executed on December 6, 1811, and witnessed by David Watson; her son William next executed a release on November 14, 1814, which was witnessed by Mary Gordon; then on May 21, 1816, her son Henry Smith executed a release in the presence of Elizabeth Gordon; and on October 29, 1818, the fourth son, John Smith, executed a release in the presence of Mary Gordon. No place name is mentioned on any of the releases but since two daughters of Alexander Gordon witnessed the execution of three of the releases, these legatees undoubtedly appeared in person for payment.

Releases of three of the daughters of Sarah Gordon Smith were executed in Xenia, Greene County, Ohio. The signatures thereon are those of Anna Smith Stevens, wife of Andrew Stevens; Margaret Smith Stevens, wife of Philip Stevens; and Mary Smith Marshall, wife of Robert Marshall, all of who would appear to have migrated from Virginia to western Ohio with their husbands. Sarah, the fourth daughter of Sarah Gordon Smith did not marry and undoubtedly remained at home to care for her father. On July 28, 1815, before distribution of her share of the legacy had been accomplished, she died, after having made a verbal deathbed will to which several members of the household attested before a Justice of the Peace in Clarksburg. She bequeathed her legacy to her brother William Smith, who reappeared and in the presence of Margaret Gordon, executed a release for his second share in the legacy bearing date of November 8, 1824, thus after a delay of more than fifteen years, finally completing the distribution. The eight releases were for \$44.00 each, or a total of \$ 352.00 in payment of a legacy of One Hundred fifty pounds, indicating an exchange rate of only \$ 2.35 per pound.

Concerning Alexander Gordon, the fifth child of Henry and Sarah Gordon, who was born on March 10, 1768, we are given the names of his children and we have been able to gather considerable other information of interest. Alexander Gordon was a boy of eight at the outset of the Revolutionary War, and he was in his mid-forties during the War of 1812. He died April 10, 1855 during the term of Franklin Pierce, when war clouds again loomed large on the horizon. Happily he escaped the horrible ordeal of witnessing the bitter and bloody Civil War into which those clouds culminated just six years after his death. His life span of eighty-seven years covered the birth and the infancy of the new nation to which he claimed allegiance. He barely missed voting in our first national election, but celebrated his twenty-first birthday before that first memorable inauguration took place and he witnessed and perhaps voted in sixteen presidential elections thereafter.

While we are not given the date of their marriage, we know that he first married Margaret Smith and from that union nine children were born. Sarah, their first child was born on January 13, 1790, and we are told that she married Wilber or William Lawrence. Our record declares his name to be "Wilber" but note that the release which he executed with his wife for her legacy is signed "William." We are told that they had two children, and we note that Sarah Lawrence inherited from her father certain property in Greencastle, Pennsylvania in which she resided when the will was written making it appear evident that their entire lives were spent in and about Greencastle. From a day book of her nephew, Jeremiah Gordon, we note that as late as 1875 he paid interest to Sarah Lawrence and she must therefore have lived to be 85 or more.

Nancy, born on October 11, 1791 married her cousin George Gordon, who predeceased his father-in-law. We are told that they had four children and we know that the \$ 1,000. legacy which Nancy received was acknowledged in the presence of a Notary in Chester, Randolph County, Illinois. Mary, who was born on January 2, 1794, married Dr. Thomas Liget to which union no children were born. He too, predeceased his father-in-law and his widow, Mary, likewise receipted for her legacy in Chester, Randolph County, IL. Both families no doubt migrated in early life.

George, the fourth child, was born on August 8, 1796. He married Martha Huston, and although he predeceased his father, our record tells us that he reared seven children. From the distribution of their grandfather's estate, we note however that releases were executed by only six of his children, indicating that one of the children also predeceased the grandfather. The releases were executed in the following order: Alexander Gordon, William Gordon, Matthew Gordon, Joannah F. Gordon Pittenger, Sarah Gordon Pool. and George Gordon. Each received a cash advance of \$ 100.00 and at the death of their widowed mother they inherited the property which she occupied, to which she was given a life interest. All of the releases were executed locally and George undoubtedly lived his entire life in property owned by his father.

Henry, we are told, was born on November 20, 1798 married Matilda Bowman, moved to Mt. Vernon, Knox County, Ohio and raised six children. Elizabeth who married James McCrea was born on January 26, 1801 and we are told bore two children. Elizabeth and James appeared in person in Antrim Township to execute a release for Elizabeth's inheritance and we believe that they had remained in the area. We also note that her brother, Jeremiah Gordon, in 1875 recorded the payment of interest to Elizabeth McCrea, further indicating that she resided nearby. Alexander II, the seventh child, was born May 6, 1803 and married Johana Fullerton who bore him eight children.

Jeremiah, the eighth child was born on January 22, 1806. He married Susan Snively whose birth date is recorded as February 15, 1812 and together they raised fourteen children. Alexander II and Jeremiah, co-executors of their father's will, purchased from his estate the two farms upon which they then resided and which they undoubtedly tilled during their entire active careers. Jeremiah died September 24, 1882 while Susan died April 25, 1888. Their bodies lie buried in the Cedar Hill Cemetery in Greencastle, PA.

Margaret, the last child of Alexander and Margaret Smith was born on March 22, 1809. She married Henry Beck and gave birth to six children. She too predeceased her father, as a result of which unfortunate circumstances we have learned the name of her children as appearing on releases as heirs of their grandfather's estate. Mary Elizabeth Beck Morrison, wife of Robert Morrison; Nancy Beck Bergfield, wife of William B. Bergfield; Harriet Beck Brashears, wife of William F. Brashears; Henrietta Beck Richmond, wife of Matthew Richmond, with their husbands, executed releases in Chester, Randolph County, IL. A son, Alexander Gordon Beck, died before receiving his legacy which was then inherited by his father, Henry Beck who personally executed a release in Franklin County, PA. Another son, Milton Beck, signed in Santa Clara, California. Whether Henry and Margaret Beck ever left the local area of their birth appears uncertain.

Did Henry, after the death of his wife, return east or were the children orphaned while the family was living in or near Antrim Township and did their two widowed aunts, Nancy Gordon and Mary Liget, and the cousin and sister-in-law of Nancy? We are told that Mary had no children of her own, thus adding credence to the probability that they went West at the invitation of their aunts, sometime after the death of their mother.

We are given no date on the death of Margaret Smith Gordon, nor does the ancestral record to which we have so frequently referred, mention that Alexander Gordon was twice married, but his original Letters of Administration and a copy of his Last Will and Testament, dated April 19, 1855 not only makes a bequest to “my beloved wife, Hannah,” whose family name has not been established, but it likewise bequests to “my daughter, Kesiah,” who married Dr. Sydenham Walker and to “my son, David Stuart Gordon,” both of whose names likewise were omitted from our record, obviously for the reason that our chronicler, as evidenced in earlier generations, appears to have largely confined his interest to his own direct lineage.

We are indebted to the late Walter M. Minnich, whose interest stems from the marriage to a great, great granddaughter of Alexander Gordon, for chronology among his personal papers which establishes for us the date of birth of Kesiah as March 26, 1830 and that of David S. Gordon as May 23, 1832, when his father was sixty-four, but we have been unable to learn the source of his information.

Kesiah would appear to have been a favorite of her father as is evidenced by her unequal inheritance from his estate. Her mother, Hannah, was given a life interest in a one hundred twenty acre property in Adams County, PA which at her death, issued to her son David, and while Hannah probably spent the sunset years of her life there, we know that fate never decreed that withdrawn mode of life for David. Both Kesiah and her husband, Dr. Walker, executed a release in Antrim Township indicating that they remained in the area.

David Stuart Gordon, in his youth moved to Hagerstown, Maryland and clerked in Armstrong's Drygoods Store. An article by General John R. King, a native of Hagerstown, tells us that David Gordon was one of the most popular young men of the town. Possessed of a beautiful tenor voice, he belonged to a group of singers who gave many charity concerts in the old Lyceum Hall. Unlike his Presbyterian forebears, General King tells us that David belonged to the old Methodist Church of Hagerstown. About 1850, when the MO-KS border trouble became acute, David moved by a spirit of adventure, quit the mercantile business and located in Kansas. It was not long before he was commissioned a Lieutenant in the Second Dragoons, later the Second U.S. Calvary.

Mr. King reports that as a prisoner of war in Salisbury, North Carolina in 1862, he was recognized by one of his reviewers, David Gordon, and again, after the Battle of Gettysburg, as an officer in the Sixth Maryland Calvary, pursuing General Lee's Army through Virginia, he again briefly crossed paths with David. During the years David had gained rank as shown by his then being referred to as Major Gordon. Then after a lapse of thirty-six years, they again met in Philadelphia at the end of the Spanish-American

War, when both had become Generals and when General Gordon was in command of Fort Myer, Virginia. After his retirement, General Gordon continued to live in nearby Chevy Chase, MD where in 1925 he was once briefly visited by his grand-nephew, Ross S. Gordon. General Gordon died Tuesday, January 28, 1930, at the age of ninety-seven years, eight months, and five days. He was buried in Arlington National Cemetery. David's penchant for music, his pleasing voice and his natural facility of making friends are family characteristics which have been much in evidence in succeeding generations and his 1832-1930 life span provides us with an outstanding example of traditional Gordon longevity.

The bequests contained in his will bear evidence that Alexander Gordon acquired considerable real estate during his lifetime and that he died possessed of three farms and three smaller properties in addition to personal property and securities', including what appears to have been a substantial investment in turnpike stocks. His life span completely covered the era of private toll road development and by devising to his widow, Hannah, his horse and barouche; he perfectly indicated the preferred mode of travel of his declining years. The original burial place of Alexander Gordon is not known, but a receipt of Jeremiah Detrick, dated at Greencastle, PA on May 14, 1888, acknowledges receipt from C. H. Gordon of seven and 75/100 dollars "for removing grand-father's body to semetry," the place of re-interment referred to being the Cedar Hill Cemetery, Greencastle, PA.

We return to Jeremiah Gordon, the eighth child of Alexander and Margaret Smith Gordon, who was born on January 22, 1806, when the return of Lewis and Clark from their historic expedition was still being awaited. Jeremiah was born three years earlier than Abraham Lincoln and contemporary with considerable number of early nineteenth century poets who achieved renown, including Browning, Emerson, Longfellow, Tennyson, and Whittier. On September 23, 1830, at the age of twenty-four, Jeremiah married Susan Snively, who was born on February 15, 1812. We find that in his mid-twenties, Jeremiah was Cornet in the Third Troop, Light Dragoons of the State Militia, and that a little later in life he was elected School Director of Antrim Township. We have evidence that Jeremiah and Susan were faithful members of the Presbyterian Church of Greencastle and their devout Christian character is beautifully illustrated in a most touchingly phrased admonition found in a letter to a distant son.

Of their fourteen children, we find that two died as children, that six others migrated westward, and that only two sons and four daughters remained in Franklin County. Of the two sons who remained in the area, neither perpetuated the family tradition of tilling the soil, and after four successful generations of ownership and occupancy, we note that at Jeremiah's death, his farm was sold to Melchi Snively and that it later became known as the Ezra Royer Farm. The old homestead farm of his brother Alexander II appears to have passed from the Gordon ownership at about the same time. We have evidence that after the raising of an extremely large family had been about completed, Jeremiah experienced some financial reverses, which following the panic of 1873, appears to have been rather acute. An examination of his carefully kept day book covering those years is most revealing. His personal needs appear to have been simple and few, yet with each

passing year he was able to maintain a balance between his receipts and his disbursements only by the increased use of credit. That bank credit was not yet readily available is indicated by the fact that instead of a few notes of substantial amount, he executed many demand notes of small amounts mostly in favor of merchants and relatives. Despite evidence of some financial stringency, we find that with each appeal from those of his distant children who suffered misfortune or want, and they would appear to have been rather frequent, his parental blessing and his financial assistance was always forthcoming.

The first child of Jeremiah and Susan Snively Gordon, Upton McCrea, was born on November 10, 1831. Upton migrated to California as a young man and on May 1, 1856 he married Elizabeth Mariner, whose mother, we are told, was of American Indian parentage. We find evidence that they reared a family of two daughters, whose Christian names were Olivia and Susan. We are told that Mr. R. P. Hotalong established Upton in a Commercial Bank in San Rafael, CA. which bore Upton's surname in its title. Upton died on July 4, 1888 at the age of fifty-six.

Amanda Susan, the second child of Jeremiah and Susan Gordon, was born on September 4, 1833 and died on December 29, 1837.

The third child of Jeremiah and Susan Gordon, Cyrus Henry, whom his nephews affectionately knew as "Uncle Cise," was born on March 11, 1835. He married Maria Eberly and they reared a family of three children. Their daughter, Clare, who married Hampsher W. Karper of Chambersburg died without issue; a son, Cloyd, married Susan Brookins and lived in the vicinity of Farmer City, DeWitt County, Illinois, where he died on October 12, 1896 at the age of thirty-three, and; William, the third child married Cora Shade of Chambersburg, who, while residing there, bore him three children. The first of whom is Blanche Gordon Fry Lohe; the second child, Jay Gordon, we are told, spent his adult life in Washington, PA., where his parents likewise lived for many years, while Joseph, the third child, migrated to California during his early manhood. Cyrus, who during his active years was a Liquor Dealer in Chambersburg, died on September 5, 1923 at the age of eighty-eight.

Marian Elizabeth, the fourth child of Jeremiah and Susan Gordon, was born on September 22, 1836. She married James McElvaney and followed him to Sparta, Randolph County, Illinois, where they homesteaded upon land which they appear to have experienced a full measure of privation and hardship. Mrs. Blanche Snodderly, a niece of Martin recalls that her Aunt Marian bore eleven children, including: Lillian, Mollie, Nellie, Jeremiah, James and Alexander, but understandably explains that the sex and Christian names of the five remaining children have become elusive, vague and uncertain recollections. Marian died on August 16, 1911 at the age of seventy-four.

The fifth child of Jeremiah and Susan Gordon, Catherine Jenet, "Aunt Net," was born on January 26, 1839. She married Henry X. Stoner, a Grain and Lumber Merchant in Waynesboro, PA. They reared three sons whose Christian names were Watson, Harry, and Bruce. Catherine Jenet died on November 15, 1896 at the age of fifty-eight.

Alexander Davidson Gordon, the sixth child of Jeremiah and Susan Gordon, was born on July 16, 1839. "Uncle Dave" appears to have been the appellation by which he was known to his kinsmen of succeeding generations, while to other associates he appears to have been known as A.D. He married Sue A. Stoner, and three children were born to this union, named: Ella, Clarence D. and Nora. Sue died when the children were quite young and we note that she bequeathed to them an inheritance of which George H. Davidson was first named administrator and guardian. Mr. Davidson, we learn married Catherine Snively, as sister of Susan Snively Gordon, hence was an Uncle of A.D., who bore as a Christian name, his Uncle's surname. We note that for many years, George H. Davidson was Treasurer of the Presbyterian Church of Greencastle. At Mr. Davidson's death, Jeremiah Gordon was named Guardian of the three above named grandchildren, and we note that the Court allowed him only \$90.00 per year for their combined care – eight cents per day, per child. A.D. was a brewer in Waynesboro, and while the exact date of Sue's death has not been established, we do have evidence that it occurred before September 1872, at which time A.D. disposed of his personal property at Public Sale and went to California to make his fortune. Of his children, we are told that Ella taught school and that Nora died in 1879. About Clarence, we can only recall that to his cousin, Ross S. Gordon, he was known as "Caddy." We are told that A.D. remarried in CA but that no children were born to that union. We have no record that A.D. ever returned to the East and we believe that for the most part, his life was spent in CA. In 1882, A.D. wrote a pathetically touching letter from San Francisco, in which he explained that he continued to be unemployed and that his wife was in Napa where she would remain until conditions improved. While expressing anxiety for the future, he reassured his mother of his well-being and promised her that just as soon as he was able to do so, he planned to secure photographs of his wife for his mother's use. The letter failed to mention the Christian name of his wife and we can only conclude that she was a complete stranger to his mother. The date of death of A.D. remains unknown to the writer.

The seventh child of Jeremiah and Susan Gordon, Mary Frances, "Aunt Fannie," was born on October 23, 1840 and married David Stoner of Waynesboro, who was a brother and business partner of Henry X. Stoner. Two daughters were born to their union. The one daughter, Agnes married Scott Cunningham of Waynesboro, where they resided, while the other daughter, Emily E. married Frank Sheiss, also of Waynesboro. Agnes Stoner Cunningham bore one daughter, Frances Esther, who married J. Carlton Jones of Waynesboro, and they too reared one daughter, Mary Agnes Jones, who married Howard A. Parker. They removed from this area and now reside in Seattle, Washington and are the proud parents of two children. No children were born to the union of Frank and Emily Stoner Sheiss. Mary Frances Gordon Stoner died on September 4, 1901 at the age of sixty.

Jeremiah Clinton, the eighth of Jeremiah and Susan Snively Gordon was born on June 14, 1842 and married Mary Henneberger. They were the proud parents of seven children, who we mention in the order of birth: Addie, who married Jacob Stine; Cecelia, who married J. Wesley Zimmerman; Ross Snively, who married Margaret Jane Crunkleton; Isaac Henneberger, who married Jessie Yount; George Carl, who married Clara McClean; Susan Virginia, who married George P. Gray; and Charles Clinton, who

married Mamie Apperson. Jeremiah Clinton served in Company K, 126th Regiment, and in Company M, 100th Regiment, PA Volunteers, in the Union Army, during the Civil War. It is noted that while appearing as Jeremiah C. on military records, J.C. was commonly addressed as "Clint" or "Clinton" and signed his name accordingly. Much of his active adult life was spent in Eastern Oregon, where he was a sheep rancher. He died on March 6, 1929 at the age of eighty-six and is buried in Cedar Hill Cemetery in Greencastle, PA.

Margaret Alice, the ninth child of Jeremiah and Susan Gordon, was born on October 20, 1843 and died on July 9, 1845, when less than two years of age.

The tenth child of Jeremiah and Susan Gordon, Cornelia Agnes, "Aunt Neal," was born on September 19, 1845 and died during October 1927 at the age of eighty-three. She married John Price of Waynesboro and reared two daughters named Mary and Sudie. Mary married Charles Shuck to whom she bore one child, a daughter named Etchen. Mary was widowed early in life while residing in the Philadelphia area, where she herself died and where her daughter continued to live until her retirement as a Librarian, after which she returned to Waynesboro. Sudie, the second child of Cornelia Agnes, married George Reuschline and they too spent most of their adult lives in the Philadelphia area where they died without issue.

The eleventh child of Jeremiah and Susan Gordon, Augustus Thompson, "Uncle Tom," was born at Shady Grove, on January 18, 1847. His first wife, Amanda Bittner, was born on October 10, 1848. They were married on March 5, 1870, and two sons were born to them. Amanda died on August 28, 1875 in her twenty-seventh year. On September 26, 1885, Augustus T. married Sallie Graham, who was born in Antrim Township on December 1, 1852 and who died in Greencastle on December 8, 1937. To their union one daughter and one son were born. During his early adult life A.T. was a stage coach driver who, like brother Cyrus, remained in Franklin County. He died on September 3, 1926 just a few months short of his eightieth birthday. The first child of A.T. and Amanda Gordon, Edward Albert, was born May 23, 1871 and on June 24th, 1892 he married Dora Kriner. Three children were born to their union. The second son of A.T. and Amanda, Lloyd Augustus, was born on August 10, 1873. On April 24, 1895 he married Cora Lernberger of Ottumwa, Iowa, and one daughter was born to them. We are told that Lloyd conducted a laundry business in Ottumwa for many years. The first child born to A.T. and Sallie Gordon, a daughter, Blanche C. was born December 9, 1886 at Mercersburg, PA. On November 29, 1906, Blanche married Charles O. Snodderly of Hagerstown Maryland. The second child of A.T. and Sallie, Thompson K. was born September 26, 1891 in Greencastle. On November 23, 1921 he married Margaret Filson of Lewistown, PA. No children were born to their union. Both they and Blanche, who is now a widow, reside in Greencastle. The three children born to Edward Albert and Dora Kriner Gordon were as follows: M. Errol Gordon, who was born August 31, 1893, and who married Dorothy Gabler of Waynesboro on October 12, 1921. Errol died on February 14, 1949 without offspring; Beatrice M. Gordon, who was born on August 17, 1895, and who on September 12, 1917 married Frank Holtzman. While told that they reside in Philadelphia, we have no record of their children, if any; and last, Eula Gordon,

who was born October 4, 1899 and who on June 30, 1925 married Scott Neady. Two sons were reared from their union: John Gordon Neady, now a resident of New Jersey, who was born in Waynesboro on May 26, 1926 and who on December 26, 1953 married Joan Waters of Baltimore, Maryland, to which from their union a daughter "Cathy" has been born; and Michael Kriner Neady, who was born in Waynesboro on October 19, 1932, who is now a resident of the Pittsburgh area and who on July 7, 1956 married Nina Yerkie, to whom son's, "Jeffrey," "Martin," and "John" have been born. The daughter born to Lloyd Augustus and Cora Lernberger Gordon, christened "Mary," was born February 7, 1904 at Ottumwa. Mary, we are told, on July 3, 1928 married Harold Reedquist at Des Moines, Iowa and that to their union, a daughter, Mary Jane Reedquist was born on October 31, 1934 at Iowa City, Iowa. On August 3, 1957, Mary Jane Reedquist married Dr. Fred Requa at Minneapolis, Minnesota. The daughter born to Charles O. and Blanche Gordon Snodderly, Evelyn C., was born on December 25, 1907. After twenty-two dual celebrations on that date, Evelyn added further personal significance to the day, when on December 25, 1930 she married George E. Smith of Chambersburg. Their two sons, Carl Gordon Smith and Charles W. Smith were born on January 3, 1932 and October 7, 1937 respectively, both at Chambersburg.

The twelfth child of Jeremiah and Susan Gordon, Ariana or "Aunt Ann." was born on October 19, 1848. Ann was fifteen when Lincoln made his immortal two minute address at Gettysburg and with her little cousin, Charlie, and with characteristic Gordon zest and courage, Ariana reports having arisen at 4 am, hitched the family horse to a buggy, and having driven twenty-six miles over the mountains of Gettysburg on that historic occasion. Ariana confesses that at that time the large crowd was her chief interest and that she missed the address, but yearned to shake hands with the President after the ceremony had been brought to an end – an end which cousin Charlie thought would never arrive. Charlie wanted to get home and when Ariana resisted his boyish impatience for action, he suggested that instead of waiting for the milling crowd to disperse, she climbed one of the poles which supported the platform where Mr. Lincoln stood, thus avoiding the long line of more sedately conforming humanity. Ariana says "When I finally grabbed the top railing, Mr. Lincoln was watching me and as he reached for my hand, he remarked: "You labored hard, but you made it." I shall never forget his two large hands clasped over mine.

Some time after her father's death, Ariana and her mother visited members of the family in California and after her mother's death, she returned to CA and never married. In August 1937, when she was nearly eighty-nine, her nephew, Ross S. Gordon, visited her near San Francisco. When reminded of her musical talent of bygone days, she stated that she still played occasionally and she graciously moved over before the piano and played several numbers reminiscent of her visitor's childhood. The date of her death has not been ascertained, but it is recalled that she was well above ninety.

The thirteenth child of Jeremiah and Susan Gordon, Florence Marie, "Aunt Flol," was born December 26, 1850. She married John Potter, who was born on September 28, 1849, and who died on June 28, 1923, while Florence died April 30, 1924. All their wedded years were spent in Waynesboro, PA. Ten children were born to them in the

order set forth below: Charles Bachtel Potter, was born in 1876 and died unmarried in 1937; Mary Suzanne, who was born on May 28, 1877 and who also remained single and died on June 5, 1911; Edwin, who was born in 1879 and who died the following year; Albert John Potter, was born on December 25, 1880 and on January 29, 1900 married Sarah Jane "Lila" Burkett. Their only child, Albert Lawson Potter was born March 17, 1913 and on June 29, 1935, married Betty Kutz, of Reading, PA. They reside in Oregon and are the parents of two daughters: Jean, born October 31, 1939 and Ann, born January 11, 1943. Sarah Jane Burkett Potter died on June 18, 1950 and sometime following the death of his wife, Albert J. abandoned his life long home in Waynesboro and took up residence with his son Lawson and family in Oregon. Berna, who was born in 1882, and died in 1887; Jeremiah Clinton, who was born in 1884, died in 1887, with just ten days separating his death from that of his sister Berna; Arthur Chase Potter, was born on February 25, 1886, was also attacked by the childhood malady with which Berna and Jeremiah were stricken, and which only he survived. Arthur remained unmarried and died in January 1941; Kenneth Gordon Potter, who was born February 6, 1888 and who married Ruth B. Shoemaker, of near Waynesboro, died without issue on March 5, 1943. He was a highly reputed Insurance Broker in Waynesboro; Frances Grace was born March 12, 1890 and died on December 3, 1907 at the age of seventeen; Cornelia Benson Potter, the tenth and youngest child, was born on January 18, 1893, and on May 20, 1916, married Jules Robert Bernd, Jr., a native of Texas. Their only child, Jules Robert III, was born on May 26, 1926 and died on May 30 of the same year. They resided in Winchester, Virginia, where for many years Jules has been a Refrigeration Engineer. Jules retired recently and they now reside in Waynesboro, PA.

The fourteenth and last child of Jeremiah and Susan Gordon, John Snively, "Uncle Jack," was born on June 17, 1852. He married Miss Dubel, of Waynesboro, who died at an early age, after which time he went to Lanark, Carroll County, Illinois, where he resided during the remainder of his life. He remarried in Illinois and his second wife bore him a son, who is also now deceased.

We have already mentioned the name of the seven children of Jeremiah Clinton and Mary Henneberger Gordon, to who we now return with considerable information. Ada, the first born child of this union, was born on June 12, 1864, and she married Jacob Stine, to which union fourteen children were born. Abram, the first of Ada's children married Barbara Cook and their seven children included: Norbert, Seth, Glenn, Louise, Harold, Ada, and Florence. Mary Elizabeth, the second child, married Roy Kell, and their five children included: Margaret, Ada, Martha, Robert and Roy, Jr. She died after suffering burns from exploding cleaning fluids. Earl, the third child, married Lelia Hoover, and their twelve children included: Iola, Emma, Paul, Lloyd, Delores, Donald, Max, Gerald, Lelia, Jean, Kenneth, and Emmert. Denton, the fourth child, first married Goldie Kauffman, to which union two children were born, named Samuel and Helen. Denton remarried after Goldie's death to his second wife, the former Beulah Beck, eleven children were born, including: Robert, who married Gladys Kauffman, and reared four girls; Ambrose, who married Peggy Decker, and reared one girl and two boys; Preston, who married LaRue Neidenthal, and reared three boys; Lawrence, who married June Downin, who bore him one boy and one girl; Roy, who was formerly married and has

one son; Hilda, whose husband was killed in the military service, has two boys and one girl; Harold, who married Mildred Stuckey, resides in New Mexico and has two girls and one boy; Marilyn, who married Richard Stouffer and has two girls; Ronald and Gloria, who remained unmarried; and Kenneth, the youngest child, who died on the day of his birth. Elva, the fifth child, married Charles Koons, and their five children include: Jacob, Ruth, George, Naomi and Roy. Elva died young and her husband remarried. George, the sixth son, married Emma Shank and they reared three children: Dorothy, Janet and Ray. Ruth, the seventh child, remains unmarried. Jacob Ross, the eighth child, married Myrtle Stoops. Hazel, the ninth child died when young. Susan, the tenth child, married Ellsworth Strite. Hampshire, the eleventh child died when young. Ada May, the twelfth child, likewise died when young. Clara, the thirteenth child, who married Franklin Byers, died on July 16, 1961 and their three children included: Gladys, Richard and Larry. The fourteenth child, John married Aliene Hess.

Cecelia, the second child of Jeremiah Clinton and Mary Henneberger Gordon, was born on September 26, 1866, and she married J. Wesley Zimmerman and from that union two children were reared. Like her niece, Mary Kell, Cecelia met a horrible death by fire on June 14, 1908 at the age of forty-one, when her youngest son was a child of two. Her first born son, Ira M. was born on July 27, 1891, studied medicine and graduated from the University of Maryland Medical School, attained the rank of Major while serving in the U.S. Army during WWI and thereafter, practiced his profession in Washington, County, MD, and resided in Williamsport most of his life. He married Josephine Cullen and two daughters were born to them: Margaret Eva, who met a tragic death when as a high school student she, with a dozen or more fellow students, was traveling in a school bus and were the victims of a grade crossing accident; while the second daughter, Lillian Cecelia, married E. Sumner Draper Jr., of Charlotte, North Carolina, where they now reside with their two children, Norman and Margaret Gordon Draper. Dr. Zimmerman was an extremely successful and beloved medical practitioner, who like his mother and elder daughter, was the victim of a violent death, of which by reminiscing with a cousin, revealed a premonition of his own tragic death several months in advance of the date thereof, which occurred on March 17, 1953, as the result of injuries sustained in an automobile accident. Ross W., the second child of Cecelia Gordon Zimmerman's two children, was born on January 9, 1906 and married Katherine Young of Hagerstown. They are the parents of three children; Betsy Ross, John, and David, and reside in Mercersburg.

Ross Snively Gordon, the third child and oldest son of Jeremiah Clinton and Mary Henneberger Gordon was born on January 21, 1868. Unlike his three brothers, he remained in the area in which he was born. In his youth, he was employed on the farm and during his early adult life, he operated a farm on a share basis and later managed his own farm, but his natural gift for making friends, his pleading personality and his interest in public affairs inevitably led him into public life. Endowed with a remarkably retentive memory, he completely recited Gray's Elegy in a country churchyard, without prompting, after he had passed his eighty-third birthday. Unlike his male forebears and his brothers, he was a staunch Democrat. He served several terms as a School Director of Antrim Township. He was a County Committeeman of his party for many years, he was twice

elected County Commissioner of Franklin County, and he served as a member of the Franklin County Draft Board by appointment of President Wilson during the first World War. He served as a Bank Director in Greencastle for more than forty years, was a member of the Reformed Church of Greencastle, and for many years was a member of its Consistory, and its Board of Trustees. A natural and interesting conversationalist, he delighted in relating the many changes which had taken place during his lifetime. Certainly they were many and varied as there is little doubt that the era in which he lived, an age of incredible invention and of industrial maturity, is without a counterpart in world history. He died on September 1, 1951 at the age of eighty-three as the result of injuries suffered in an automobile accident. His wife, Margaret Jane "Jennie," was the daughter of David and Sarah Crunkleton. Four children, all girls, were born of this union and when the youngest child was little more than a year of age, "Jennie," beloved wife and mother, was suddenly called to her eternal home and to the four overwhelmed children she left behind, their father showered the love which under normal circumstances only a mother could bestow. Although he survived "Jennie" by forty-seven years, faithful to her memory he never remarried. They are buried in the graveyard adjoining Shanks Church, several miles south of Greencastle.

Naomi Pearl, the first child of Ross S. and Jeannie Gordon. was born on December 5, 1894. She married Walter M. Minnich, a Greencastle banker and to them two daughters were born. Anna Jane, born on April 19, 1923 married James A. Noble of Murrysville, PA. To them on January 11, 1949. was born a son, Andrew Gordon Noble, great, great, great, great, great, great grandson of George Gordon of Scotland, by whose birth was reversed the all-girl history of the two preceding generations of his mother and grandmother. A second child, Beth Ann Noble was born on October 24, 1959. Janet Louise, the second daughter of Walter and Naomi Minnich, was born on December 12, 1926 and married Howard Gift of Greencastle. Three children have been born to them, including David Howard Gift who was born on September 11, 1952; Brian Minnich Gift, who was born on May 31, 1955; and Amy Jean Gift, who was born on October 31, 1958. Sarah Rebecca, the second child of Ross S. and Jennie Gordon, was born on August 30, 1897. She taught in the public schools of Antrim Township for sixteen years after her graduation from Shippensburg State Normal School. On June 16, 1934 she married Jacob Hoffman of Hagerstown, MD where she thereafter made her home. Mary Susan, the third child of Ross S. and Jennie Gordon, was born on August 4, 1900, she also became a teacher after her graduation from the Shippensburg State Teachers College, and like her sister Naomi, Mary married a Greencastle banker, Warren C. Coffey. Hazel May, the fourth and last of the children of Ross S. and Jennie Gordon, was born on February 25, 1903. She died on July 23, 1906 at the age of three and a half.

Isaac Henneberger Gordon, the fourth child of Jeremiah Clinton and Mary Henneberger Gordon, was born on November 24, 1869. He went to Champaign County, Illinois as a young man. Where he spent his entire adult life. Like his older brother, Ross, he was possessed of a splendid memory and delighted in reciting what he termed his "readings," of which he had many, none of which he ever read, but which he recited from memory with fluent and effective rendition. Isaac died on March 14, 1948 at the age of seventy-nine. Like his brother George, Isaac H. Gordon is buried in Mt. Olive Cemetery,

Mayview, Illinois. Isaac H. and his wife Jessie Yount Gordon were blessed with three children. Maurice, who married Edith Wilson and who resides in Malibu, California; Lorene, the second child, after achieving success in secretarial work in Urbana, Illinois, developed an urge to return to the Cumberland Valley which her ancestors knew and loved. Its advantages were no doubt extolled by a native son, Frank T. Warrenfeltz, to whom she was married on November 26, 1954. They reside in Boonsboro, Maryland where Frank is an esteemed citizen and retired merchant. Helen, the third child, married William Lane, and bore him two daughters, Linda and Karen. They reside on the farm near Urbana, Illinois, upon which Isaac and Jessie Gordon reared their family and where they died. Linda Lane is now married to Scotty Kirby and they are the parents of two sons, Kenneth Scott Kirby (date of birth not given) and David Lane Kirby born on September 5, 1964. Karen Lane, daughter of Helen and William Lane, married Charles Heath and they are the parents of three children: Melinda Heath born on June 23, 1963 at Champaign, Illinois, Pamela Heath born on January 12, 1965, and Charles Chandler Heath, born on July 7, 1966.

George Carl, the fifth child of J. Clinton and Mary Henneberger Gordon, who was born on January 3, 1872. Like his brother, Isaac, George went to Champaign County, Illinois when but a youth. He remained there and married an IL girl, the former Clara McClean, and like Isaac, he died there and was buried in the Mayview, IL Cemetery. Four children were born to George C. and Clara Gordon. Glenn H., the oldest of their children, married Ruth Green, by who he was blessed with a family of six children, including twin girls, whose names appear last among the names of their children which follow: Elizabeth, Glenn Jr., Mary Margaret, Donald, Jean and Jeanette. Mary, the second child of George and Clara, married Rollo Leigh. Herbert, their third child, married Dorothy Webber, and shared with her the parentage of two children whose names are Thomas Herbert and Charlotte Virginia. Hilda, the last child born to George and Clara, married Lawrence Wood, and to them was born one child, whose name is Judy.

Susan Virginia, the sixth child of J. Clinton and Mary Henneberger Gordon was born on February 15, 1873. While visiting California, she happily met, and on February 16, 1909, married George Putnam Gray, who was born on February 4, 1877 in Fremont, Dodge County, Nebraska. George was a student at Pomona College at the time of his marriage, where he received his B.S. Degree in 1910 and in 1911 received his Master's Degree from the University of California. George P. and S. Virginia Gray are the parents of two children. Their oldest child, Warren Putman Gray was born on August 15, 1911, while their second child, Helen Virginia Gray was born on March 1, 1915. George P. Gray enjoyed a wide and fruitful experience in Agricultural Chemistry, including extensive research and teaching at the University of California, and other state agencies and educational institutions in the San Francisco area. His abilities quickly won him a professorship at the University, in addition to which he appears to have found time for considerable experimental work and scientific treatises. In later years he was identified with several of the larger manufacturers of commercial fertilizers, fungicides and insecticides. On March 16, 1946, Warren Putnam Gray and Delores Loraine Cole were united in marriage. They reside in Oakland and are the parents of one child, Susan Jane Gray, who was born on April 16, 1947. On February 2, 1946, Helen Virginia Gray

married Jonathan Burdette Brown of National City, California. They reside in Berkeley and are the parents of two daughters. This first, Bonnie Virginia Brown, was born on December 27, 1948, while her sister, Glenda Carol Brown was born on February 19, 1952. Susan Virginia, or "Aunt Virginia," as she was known to her nieces, died on August 3, 1957. George P. Gray is the only living member of his generation of the family into which he married. He now resides in Oakland, California.

Charles Clinton, the seventh and last of the children of Jeremiah Clinton and Mary Henneberger Gordon, was born on June 13, 1874, served in the U.S. Army during the Spanish American War, and thereafter settled in Champaign County, Illinois, and married Mary Apperson of the area. To his intimate acquaintances, Charles Clinton was known as "Clint," and like his brother Isaac, or "Ike" as he was best known, Clint was infectiously good humored. Charles Clinton and Mary Apperson Gordon were the parents of eight children whom we list in the order of their birth: Harold Clinton, born May 9, 1906, who married Grace Isabelle Munter; Edith Viola, born July 30, 1908, who married Glen Ernest Chapman; Hazel Naomi, born December 24, 1909, who married Michael Jay Coon; Florence Lavaugh, now deceased, was born May 11, 1912, married Dale Donald Amsden; Frances Virginia, born January 5, 1917, who married Elmer H. Anderson; Warren Raymond, born September 7, 1919, who married Edith M. Smith; Lawrence Earle, born February 20, 1921, who married Rita Sanguineti; and Mary Evelyn, born January 24, 1923, who married Melford D. Taylor. In addition to their eight children, Charles Clinton and Mary Apperson Gordon are survived by seventeen grandchildren as follows: To Harold C. and Grace I. Gordon, a daughter, Donna Louise, born on April 13, 1928, who on September 26, 1954 married Joseph Wayne Ray; the second daughter of Harold and Grace Gordon, Patricia Ann, born on August 25, 1934 and on November 15, 1952 married Harry Paul Garrett. A third child, Nancy Kay was born to Harold and Grace Gordon on February 9, 1938. Glen E. and Edith Gordon Chapman are the parents of one child, James Wesley Chapman, who was born on October 20, 1938. Michael Jay and Hazel Gordon Coon also are the parents of one child, Mary Jo Coon, who was born on June 10, 1941. Dale D. and Florence Gordon Amsden are the parents of two children, Richard Dale Amsden, born November 11, 1935, and Geraldine Ann Amsden, born June 20, 1939. Elmer H. and Frances Gordon Anderson are the parents of three children. The first, Joyce Vone' Anderson was born September 8, 1938. The second, Charles Gordon Anderson was born August 10, 1945 and their third child, Clark Gary Anderson was born on May 3, 1951. The three children of Warren R. and Edith M. Gordon are: Raymond Clinton Gordon, born January 31, 1947; Marsha Ann Gordon, born August 3, 1951; and Daniel Warren Gordon, born May 15, 1953. To Lawrence Earle and Rita Gordon, have been born: Bruce Gerard Gordon, whose birth date was January 24, 1953; and John Charles Gordon, born May 19, 1954, in addition to whom two children died in infancy. Melford D. and Mary Gordon Taylor are the parents of Anita Jean Taylor, who was born June 9, 1947, and of Lee Allen Taylor, who was born July 11, 1950.

Mary Apperson Gordon, who died January 28, 1927. predeceased her husband by twenty-four years. Her helpmate, Charles Clinton Gordon, died February 10, 1951 and together they lie in Mt. Olive Cemetery, Mayview, Illinois.

Michael Gordon

(Forebears Unknown)

Michael Gordon for many years owned and occupied the Antrim Township farm, west of the Greencastle and Williamsport Pike, near Worleytown, Franklin County, PA, now owned by Mr. & Mrs. J. A. Hoffman.

From his grave stone in Green Hill Cemetery, Greencastle, PA, we learn that Michael Gordon died on January 9th, 1978, aged _____ years, eleven months and twenty-one days. While we are able to establish the day of his birth on January 30th, the stone marking the place of his burial is very badly eroded at the area reciting the years of his life, and the year of his birth has not yet been established by the writer.

We have not yet been able to learn the names of his forebears, but it would appear that he was born very early in the nineteenth century and that very probably he was a grandson or possibly a great grandson of George Gordon of Scotland, who was born in 1698 and who settled in the New Antrim in 1734.

Harry Clinton Gordon, 101 Cypress Street, Hagerstown, Maryland, on December 19, 1962, while celebrating the ninetieth anniversary of his birth, in a hospital bed, recited from memory most of the following data pertaining to his grandfather, Michael Gordon,

and his family of fourteen children. From the limited information thus far gathered from nearby burial grounds, it would appear that the sequence of birth as enumerated by our nonagenarian informant is correct, thus bearing testimony of a remarkably alert mind capable of surmounting both age and the physical disability of the moment.

Children of Michael Gordon

1. Anna, who married Jeremiah Stahl, a shoemaker, to whom she bore four children. They lived and died on land which had been a part of the Gordon homestead. From their gravestones in Green Hill Cemetery, we learn that Anna was born in 1831 and that she died in 1919, at the age of 88.
2. Joseph, who as a young man, moved to Johnstown, PA. We are told that he had two sons and that he died while in military service.
3. Henry, who migrated to Mt. Morris, IL.
4. John, whose marker is Cedar Hill Cemetery, Greencastle, PA, establishes the date of his birth as July 3, 1841, and the date of his death as August 6, 1896, at the age of 55. An adjoining stone reveals to us that his wife, Emma V. died on November 13, 1926 at the age of 86. We are told that they were the parents of five children, three of whom were boys.

5. Daniel Webster, who was born on May 12, 1843, who married Catherine Kuhnes, and who as a young man tilled the Antrim Township farm upon which he was born and where he died on May 18, 1878, aged 35 years and six days, a few days after returning from the Philadelphia World's Fair, where he was believed to have contacted typhoid fever. His body lies buried in the graveyard of nearby Shank's Church. Soon after her husband's death, the widowed Catherine sold her personal property, and with her brood of five children, moved to the State Line Road, a half mile east of Mason-Dixon, from where her children attended old Greenmount School.

6. Calvin, who married Alice Maugans, with whom he migrated to Winatchie, Washington. A daughter born to their union lies buried in the Shank's Church graveyard

7. Michael D., whose gravestone in Cedar Hill Cemetery records his death as having occurred on October 4, 1865 at the age of 19 years, 8 months and 17 days, thus establishing January 18, 1846 as the date of his birth. We are told that while he was leading a colt or young horse to a watering area, west of the house, he had thoughtlessly chained his wrist with the end of the lead chain and that the animal unexpectedly took fright and dragged him to his horrible and untimely death.

8. Laura, who married John Elliott, and she, like her sister Ann, built on land taken from the Gordon homestead, from where she later migrated to Kansas or Nebraska. Laura is believed to have had one daughter.

9. Susan, who married Elisha Miller, to whom she bore two sons and two daughters. Sue and Elisha remained in the area and although we have not yet located their graves, we are told they are buried in Green Hill Cemetery.

10. Sally, who married John Cunningham, and who following her marriage, resided near Bakersville in Washington County, Maryland. Sally lies buried in the nearby Bakersville Church graveyard.

11. Rebecca or "Aunt Beckie", who married Jeremiah Wilt, with whom she migrated to Mt. Morris, Illinois.

12. Cornelia, who as a growing girl, while standing on the west porch of the stone house in which she was born, was mortally wounded from the accidental discharge of a gun in the hands of a neighbor, who, in preparation for slaughtering an animal for beef, was engaged in displaying the weapon to a bystander who had commented upon the beauty of the firearm.

13. Elizabeth, who married Leonard Alleman.

14. Catherine, who married Joseph Teeter, and who is believed to have remained in the Greencastle area.

Children of Jeremiah & Anna Gordon Stahl

(Sequence of birth unknown)

1. Mary Jane, who married Daniel W. Cline and who with him, established a home on a portion of the land which Mary's parents had acquired from her grandfather, Michael Gordon. Mary and her husband were buried in the Shank's Church graveyard and her gravestone indicates that Mary died on August 20, 1907. As long as he lives, the writer will remember with vivid clarity many details of the prolonged funeral service which preceded Mary Jane's burial and which indelibly impressed themselves upon the receptive mind of a boy of nine, who on an extremely hot summer day, accompanied by his parents, shared with them, their tribute of respect for a deceased friend and neighbor.
2. John Michael, whose life span was spent in the home in which he was born. Rather late in life married Mary Cline of Washington County, MD to which union a daughter was born.
3. Unknown child.
4. Unknown child.

Children of John Gordon, son of Michael Gordon

(Chronology not established)

1. Bruce N. Gordon, a widely known Greencastle Livestock Dealer was buried in Green Hill Cemetery.
2. Effie Gordon Crunkleton, whose monument in the Shank's Church graveyard indicates that she was born during the year 1864 and that her death occurred during the year of 1936. Effie was the wife of Lewis Crunkleton, and spent all or most of her married life with him on land which had been part of the original Gordon Homestead.

4. Albert Gordon, who as a young man, migrated westward.
5. Rensch Gordon, who likewise abandoned his native state early in life. Children of Sarah Smith and (1) Josiah Smith (one child??)

We want to extend a very special thanks to Mr. Jacob Hoffman of Hagerstown, Washington County, MD for the hours he has spent trying to find the father of our Alexander Gordon (husband of Elizabeth Bovey and Sarah Smith). Mr. Hoffman married Sarah Rebecca Gordon, daughter of Ross S. and Jennie Gordon. She was born August 30, 1897 in Greencastle, Franklin County, PA. She taught in the Public Schools of Antrim Township for 16 years after her graduation from Shippensburg State Normal School. On June 16, 1934 she married Jacob Hoffman of Hagerstown, MD.

Mr. Hoffman feels that George Gordon, son of Alexander Gordon IV and Margaret Smith must be the parents of Alexander. To date, we have been unable to provide this conclusively. Also he has helped us with some of the children of Alexander Gordon and wife # 1, Elizabeth Bovey. as follows:

Child # 2 was born August 11, 1851 in Pennsylvania and she married John Henry Minnebraker, not Minnebraker. Martha J. Gordon was born March 29, 1853 and married William H. Uhler. Mary A. married Reverdy J. Stemm. Mr. Hoffman was able to get a certified copy of the obituary notice of Mrs. Joanna Pittinger (daughter of George IV and Martha Huston Gordon) as follows:

Mrs. Joanna Gordon Pittinger, widow of the late John Pittinger, died at her home on East Baltimore Street Sunday afternoon at 4 o'clock, following a prolonged illness with the diseases incident to age, aged 77 years. Mrs. Pittinger had not been in good health for a number of years and recently her condition had been serious. She was a native of Antrim Township, a daughter of the late George Gordon and had spent the entirety of her long and useful life in this community where she was widely known and respected. For many years she had been a faithful member of the Methodist Church here. Her husband died many years ago, but she is survived by four sons: Harry C, Pittinger, of town; M.H. and

John Pittinger of Carlisle; and Edward L. Pittinger of Harrisburg. The funeral was held yesterday afternoon at 2 o'clock. Dr. G. M. Klepfer, Pastor of the church, and interment was made in Cedar Hill Cemetery in Greencastle.

The following are a few Gordon corrections and additions made by Mr. Hoffman to the original Gordon History.

Anna Elizabeth Gordon Minnebraker was born in 1851, not in 1852.

Charles H. and Rhoda King Minnebraker had no children and are buried in Boonsboro, Maryland.

Ida Florence Minnebraker Koontz was buried in Cedar Hill Cemetery in Greencastle. She and Watson had no children.

Lillie May Minnebraker Horst was born March 28. I said William G. Horst but he shows her married to Isaac G. Horst. They were married November 17, 1892.

Ruby Celeste Mauck was born February 28, 1918 and married in 1938.

Tammy Lynn Heffner was born in 1966.

Dorothy Isabel Mauck had one daughter, who was born in 1941.

Charles Bernard and Ruth Lefevre Minnebraker had no children.

John Norman Minnebraker married on March 4, 1922 and died September 28, 1971 and is buried in Rest Haven Cemetery in Hagerstown, MD. He and Daisy May had no children.
